## **Code Of Conduct**

Please find below the code of conduct for boaters who purchase a seasonal slip at Rawley Resort:

- Safety First: Boaters are required to follow all safety rules and regulations set by
   Transport Canada and other relevant authorities. Boaters must operate their vessels in a
   safe and responsible manner at all times.
- 2. Respect for Others: Boaters are required to show respect for other boaters, marina staff, and guests at all times. This includes obeying noise regulations and not disturbing the peace and guiet of others.
- 3. Cleanliness and Maintenance: Boaters are required to maintain their vessels and slips in a clean and orderly condition. Any waste, trash, or debris must be disposed of in a

- proper manner. Any damage caused by the boater to the slip or surrounding area must be repaired at their expense.
- 4. Use of Amenities: Boaters are granted access to the amenities provided by Rawley Resort Marina and Spa, including the pool, hot tub, gym, and boater shower. Boaters must use these amenities responsibly and in accordance with any posted rules or regulations.
- 5. Speed Limit: Boaters are required to obey the speed limit set by Transport Canada and any other relevant authorities. The maximum speed limit within the marina is 5 knots.
- 6. Parking: Boaters are required to park their vehicles in designated parking areas only. Parking in other areas, including the boat launch, is strictly prohibited.
- 7. Insurance: Boaters are required to carry liability insurance for their vessels and property, and to provide proof of insurance upon request.
- 8. Security: Boaters are required to keep their vessels locked and secured at all times. The marina shall not be held liable for any damage or loss caused to the boater's property.
- 9. Non-Compliance: Boaters who do not comply with the code of conduct may be subject to corrective action, including the revocation of slip rental privileges.
- 10. Boat Rental and Subleasing Prohibited: Please be aware that boat owners are strictly prohibited from renting out, sharing, lending, or subleasing their boats or slips at Rawley Resort.

A Non Refundable deposit of \$1000.00 is required to reserve your slip for the 2026 season.
